Membership Agreement

Approved January 1, 2021 – Updated November 2025

We agree to the following provisions:

- 1. Term:** All Memberships shall commence on April 1, of the current year or the date after April 1, of the current year as signed below and shall terminate on March 31, of the following year, unless terminated sooner as herein provided.
- 2. Dues:** The Member understands and agrees that he or she shall be responsible for Club dues through March 31, of the following year and that membership is being offered only on a yearly basis.
- 3. Rules and Regulations:** The Member understands and agrees that his or her Membership shall be governed by the Policies and Procedures of WMT Group, Ltd. It shall be the responsibility of the Member to become familiar with these documents which are available and posted at the clubhouse. Failure to follow Club policies could result in suspension or termination of one's membership. The Policies and Procedures of the Club may include other essential information about the Club membership that members should be familiar with.
- 4. Payment for Goods and Services:** The Member understands and agrees that he or she shall be responsible for the payment of all charges for goods and services incurred by the Member and family members of the Member. The Member's right to contest any charges for goods and services shall expire 30 days after presentation of an invoice for such goods and services to the Member.
- 5. Indemnity:** The Member shall defend, indemnify, and hold the Club harmless from and against any claim, loss, expense, or damage to any person or property in or upon the premises of the Club or any area allocated to and used by the Member of the club or his or her agents, employees, or invitees, arising out of the Member's use of the facilities of the Club, or any act or negligence by the Member or his or her employees, agents or invitees, excepting from such indemnification claims arising out of acts or omissions of the Club, or its agents, employees, contractors or invitees.
- 6. Collection costs:** In the event that any collection action is commenced to collect any unpaid balance due the Club, the member agrees to re-imburse the Club for its costs of collection including reasonable attorney's fees, court costs, and any other reasonable collection fees or charges.
- 7. Children:** All children and stepchildren of the Member who are 18 years of age or younger shall be included in the Member's regular Family membership. Children and stepchildren who are 22 or under and full-time students are also included. The Club also extends membership, as part of a family package, to disabled adult dependents of the Member.
- 8. Benefits of Membership:** Unlimited golf with no additional charge except for outings. Priority tee times on weekends and holidays, discounts for club outings, apparel, event room rental, and/or food and beverages as determined by the Board of Directors and/or Club Managers.

Completion of the below information is with the acknowledgement that you have read and understand the provisions listed above and the Golf Course Policies (on other side of this form). All individuals included in the membership shall also be held responsible for the above provisions. Failure to follow these provisions and/or Club policies may result in suspension or revocation of membership privileges.
